

## How to use our services

### 1 Request an appointment

Stop by the office or visit our website to fill out an intake and fact sheet. Gather any documents related to your situation and submit them with your request for an appointment.

### 2 Meet with one of our experienced interns

You'll get an appointment with one of our legal interns, either a second or third-year law student. Our interns are supervised by full-time Indiana-licensed attorneys. During the appointment, we will assess your situation and offer possible options.

### 3 Work with us to resolve your situation

We'll evaluate your case and explain your options so you can decide what you want to do. Things we commonly do for clients include preparing agreements and other legal documents, negotiating settlements, and representing clients in court.

### Renting and leases

Many students rent off-campus properties during their time at IU. SLS offers a free lease review so you can be sure you know what's in your lease. Additionally, SLS can assist you with landlord disputes.



### Auto accidents and tickets

Always keep important documents, such as your driver's license, car registration, and proof of insurance, with you. If you receive a citation or court documents at the scene or after an accident, come to SLS for advisement.



### Criminal citations

Be mindful of public intoxication, illegal transportation, and consumption by a minor laws, among others that are related to alcohol. The potential consequences of these laws include fines, community service, license suspension or revocation, and jail time. We can help you navigate the judicial system if need be.
